**MEMBERSHIP APPLICATION – DIRECT COMPANY**

Direct Company Membership in TCA is restricted to Subcontractors and Suppliers. These are defined as companies or individuals whose majority primary work is predicated upon a contract with another entity who is in a direct contractual relationship with the owner of a construction project. It includes individuals or companies which contract with other subcontractors and it includes individuals or companies which contract to sell materials or equipment to subcontractors. Eligibility for direct membership is subject to approval by the TCA Board of Directors. A portion of the dues paid to TCA is non-deductible due to lobby tax rules. For the fiscal year 7/1/2017 - 6/30/2018, TCA estimates that the non-deductible portion of dues paid to TCA is \$95.00. Direct Company Dues are \$1,000 per fiscal year.
